COURSE SYLLABUS

Students please note that this is Elective course. Recognized Prior Learning (RPL) for this course will be recognized. Students may do this course by (a) studying the course via Tubeclasses and using the (free) MOOC courses from leading universities as supplementary delivery vehicles of the course content (\$250 per course); OR (b) undertaking similar courses elsewhere (including accredited MOOC Courses) and having the assessments suitably externally proctored (via organizations such as ProctorU); and then applying to Calwest for credit towards their degree program (\$25 per course); OR undertaking similar courses elsewhere (including accredited MOOC Courses) and undertaking 'challenge exams' at Calwest university (\$250 per course). Students may also undertake similar courses in other accredited universities for credit (\$25 per course). Please note there are limits to the maximum credits allowed in graduate programs.

1. Course Description

This course will highlight the critical legal and business issues entrepreneurs face as they build and launch a new venture. In this course, students will explore real world scenarios, and address the legal and business issues that entrepreneurs face, from the moment they conceive of the "million-dollar idea" to all of the important junctures along the path to success. This course addresses the legal aspects of entrepreneurship, and is appropriate both for entrepreneurs and lawyers who hope to represent entrepreneurs. Entrepreneurs face many challenges as they pursue a new business idea. With the right legal tools, they can take steps that provide significant legal protections and avoid future liability. Among other subjects, the course will cover American law on choice of entity (corporation, limited liability company, partnership, sole proprietorship), selection of a company name and trademark, protecting intellectual property of the business with patent, trade secret, trademark and copyright law, structuring agreements among owners, venture capital and other equity and debt financing arrangements, risk management, and the relationship between attorneys and entrepreneurs. In addition to discussing applicable legal rules, the course will focus on practical steps entrepreneurs and their lawyers can take to build and protect a new venture. The goal of the course will be for students to have a better understanding of practical ways they can protect a new venture and spot potential issues from a business-legal perspective.

3. Learning Objectives

- 1. Students will explore real world scenarios, and address the legal and business issues that entrepreneurs face.
- 2. Students will address the legal aspects of entrepreneurship.
- 3. Student will learn to use the right legal tools, so that entrepreneurs can take steps that provide significant legal protections and avoid future liability.

- 4. Students will cover American law on choice of entity (corporation, limited liability company, partnership, sole proprietorship).
- 5. Students will consider the relationship between attorneys and entrepreneurs.

4. Learning Outcomes:

To successfully complete this subject, a student should be able to:

- 1. Understand the basic principles of copyright and intellectual property as applied to new business ventures.
- 2. Understand the legal requirements relating to trades descriptions, sales of goods and distance selling.
- 3. Understand the basic legal regulations applied to data protection and privacy; understand the concept and application of standard term contracting in business, the key contractual terms and terms deemed unfair at law.
- 4. Understand the methods by which a business may pursue payment of debts and the potential penalties for late payment of commercial debts; understand the regulation of health and safety in the workplace.
- 5. Understand the legal requirements involved in lawfully hiring, managing and dismissing workers or employees.
- 6. Demonstrate legal research skills, the ability to analyze legal problems and to apply problemsolving techniques to hypothetical problems.
- 7. Demonstrate the ability critically to evaluate legal principles and law in practice.

8. Assessment

There will be **Continuous Assessments** done throughout this course.
